ALL PARTICIPANTS IN THE 8K FOR 88-CRIME AND RELATED EVENTS ("Event") ARE REQUIRED TO ASSUME ALL RISK OF PARTICIPATION IN THE EVENT BY SIGNING THIS GENERAL RELEASE AGREEMENT: The undersigned athlete ("Athlete") on behalf of himself/herself and on behalf of Athlete's personal representatives, assigns, heirs, executors, hereby fully and forever releases, waives, discharges and covenants not to sue Blue Pants Racing, Pima County, Pima County Natural resources, City of Tucson, Tucson Parks and Recreation, USATF and all municipal agencies whose property and/or personnel are used and all other sponsoring or co-sponsoring companies or individuals related to the 8K for 88-Crime(collectively "Releasees") from all liability to the Athlete and his/her personal representatives, assigns, heirs and executors, for all loss(es) or damages(s) and any and all claims or demands therefore, on account of injury to the Athlete or property or resulting in the death of the Athlete, whether caused by the active or passive negligence of all or any of the Releasees or otherwise, in connection with the Athlete's participation in the Event. The Athlete represents and warrants that he/she is in good physical condition and is able to safely participate in the Event. The Athlete is fully aware of the risks and hazards inherent in participating in the Event and hereby elects to voluntarily compete in the Event, knowing the risks associated with the Event. The Athlete hereby assumes all risks of loss(es), damages(s), or injury(ies) that maybe sustained by him/her while participating in the Event. The Athlete agrees to the use of his/her name and photograph in broadcasts, newspapers, brochures and other media without compensation. The Athlete acknowledges that the entry fee is non-refundable and non-transferable. In the Event the Event is delayed or prevented by reason of fire, threatened or actual strike, labor difficulty, work stoppage, insurrection war, public disaster, flood, unavoidable casualty, acts of God or the elements (including without limitation, hurricanes, tornadoes, earthquakes), or any other cause beyond the control of Blue Pants Racing there shall be no refund of the entry fee or any other costs of the Athlete in connection with the Event. The Athlete hereby grants to the medical director(s) of the Event, and his/her agents, affiliates and designees, access to all medical records (and physicians) as needed and authorizes medical treatment as needed.
